The student driver MUST:

- (A) Use a licensed motor vehicle, which carries a valid automobile Third Party Liability insurance as required under Alberta legislation AND a minimum limit of two million dollars (\$2,000,000).
(B) Provide the school board with prompt written notice, with particulars, of any accident arising out of the use of a licensed motor vehicle during a trip on board-related business.
(C) Be aware that the school board's Excess Automobile Liability insurance comes into effect only after the vehicle owner's primary Third Party Liability insured limit has been exhausted.
(D) Be aware that any damage to the volunteer's vehicle, the cost of any insurance deductible or premium adjustment as the result of an accident while the vehicle is being used on board-related business is NOT covered by the school board's Excess Automobile Liability Insurance.
(E) A school student, with prior parental/guardianship consent, in writing and retained at the school on a Board approved form, may use their private vehicle to transport themselves to/from co/extracurricular events such as practices, games, tournaments.
(F) No school student, irrespective of age, may drive a private vehicle transporting other students on an approved co-curricular or extracurricular trip with the exception of siblings who have obtained prior parental/guardian approval in writing.
