- Insurance is a major cost 500,000 to 2.5 million in past 4 yrs.

Question by Cheyanne Caton regarding the survey? 4-day, 4.5 day and early care. Is early care still an option? Answer: Currently being assessed.

Q: Will there by another High school in area? A: Likely Meadow Ridge area
Cori Thompson question - Felt there was limited information available for people to read prior to completing the survey. A: Board response - looking for general interest and opinions of teachers vs. parents. Agreed survey could have been better - but Board looking for a general overview of interest to move forward and provide further detail.

Board and parents interested in an option beyond babysitting
Parent interest in another viable option for childcare in the community.
More and more days per year that parents are needing to find childcare due to PD days/holidays etc.
Discussion regarding the increase of days off school - Board member and staff state - 5 minutes added to each day to make up for the week of lost learning in April for extra week off school.

Costs have increased - budget stay relatively the same over the past 4 years. Education board told by gov't to spend the surplus or gov't would take away the money. Board covered bussing, facilities etc. Board now at end of surplus and are stretching budget.

Wafaa Abdallah question - In the CBE monthly meeting to be attended once per year by school council members. Board would ask council members thoughts/opinions etc. more engagement between two groups - has FSD looked at collaborating with council members? There is an Online meeting - minimum 3/year Next date is Nov. 14

FSD division is a Flag ship for what goes on in the province.
Barb asked Stacey Swanson (principal of CIM) why cost of sports teams so high? A: Reasons include bussing and guest teacher (sub to cover teacher going with the sport team etc.) Possible fundraiser.

Previously CIM was interested in partnering with other schools to have speaker Paul Daves - $50 \$ /$ school (TV/OHS) (other expenses covered by grant) to have Paul Daves present - However, no longer responding to Barb's messages - will continue attempts to contact.

Questions surrounding why school council must maintain the playground. Apparently every four years the pea gravel must be removed and replaced at a cost of 10-15,000\$. Why is the school individually and student council responsible for the bill?

A: Depends on the deal signed up for 10-15\$ every four years. Admin and council looking into options.
